# The RLS Club was formed in 1920 by those who had known Stevenson and who wanted to care for his memory.

The Club's main objective is 'to foster interest in Stevenson's life and works'. Since 1920 this has

been met by exhibitions, lectures, readings, literary competitions, and the maintenance of the first Edinburgh RLS Museum at his birthplace (8 Howard Place) from 1925 to 1964 when the Club's collection of RLS memorabilia was transferred to the City of Edinburgh's Writers' Museum in the Lawnmarket.

Since 1920, the Club has held an annual RLS Dinner or Lunch at which literary and public figures like Walter de la Mare, John Buchan, J.B. Priestley and Ludovic Kennedy have spoken.

In 1985, on the Centenary of *A Child's Garden of Verses*, the Club launched an international appeal which raised funds

- to create a memorial to RLS in West Princes Street Gardens in Edinburgh designed by the Scottish artist-poet lan Hamilton Finlay in the form of a coppice of birch trees round a simple stone column, this memorial was inaugurated in 1989.
- to endow the RLS Memorial Trust to help children with respiratory diseases a 'living memorial'.

In 1994 the Club played an important part in the Centenary of the death of RLS, when the writer was celebrated in a host of events in many countries.

In 2000 the Club marked the 150<sup>th</sup> anniversary of the birth of RLS with events and the publication of a *Birthday Book*.

The Club currently organises events throughout the year and publishes the *RLS Club News* three times a year. Whenever possible, the Club arranges additional benefits for Members, such as discounts on RLS-related purchases.

The Club, which has members world-wide, has close links with the RLS Club of Monterey, California, and is twinned with the Association sur le Chemin de RLS in the Cevennes, France.

The Club is always eager to welcome new members, whether beginners or established enthusiasts, so that enjoyment of his writing will be maintained and enhanced wherever and whenever possible.
